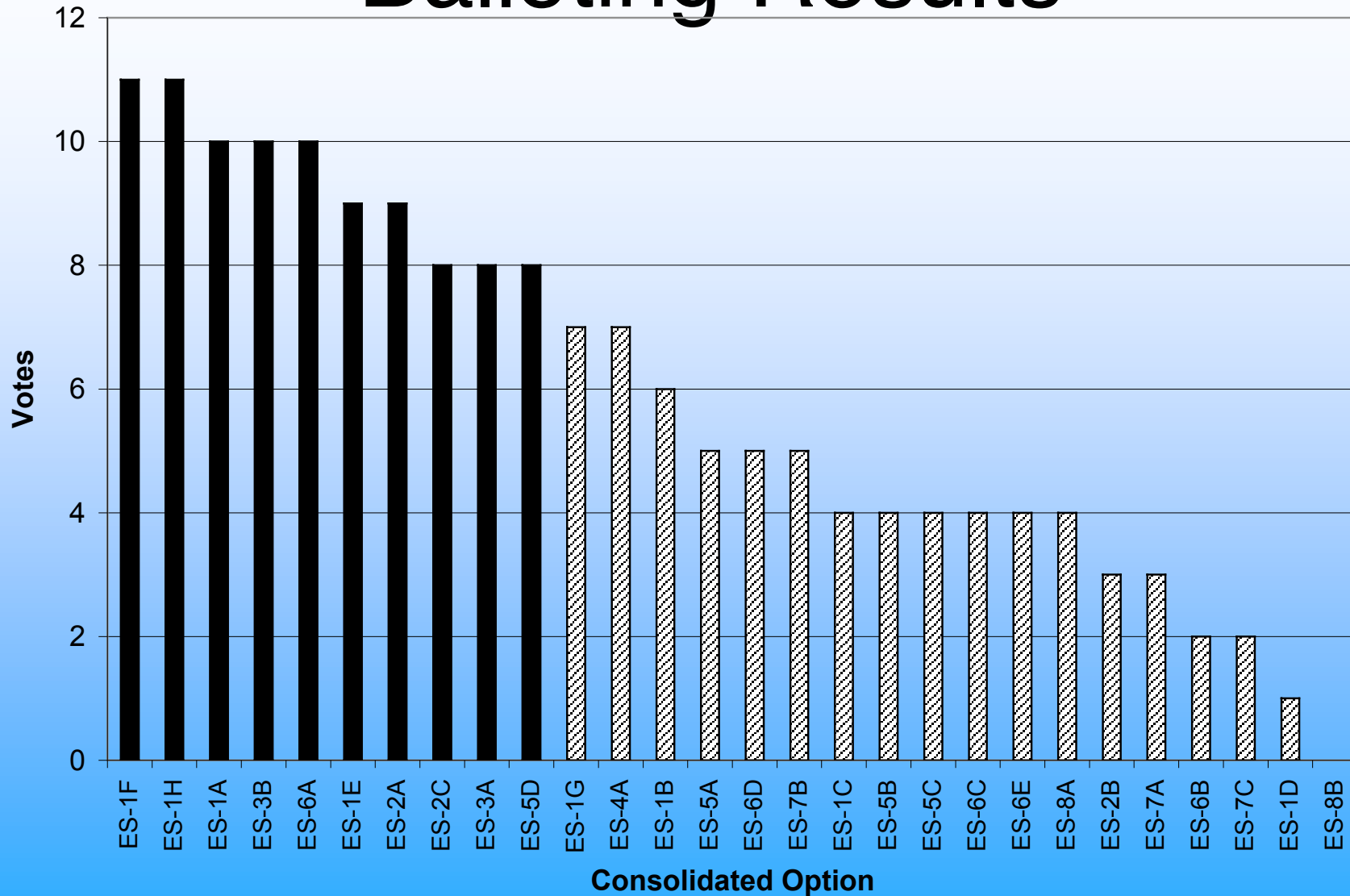
# Inventory and Forecast of Colorado GHG Emissions

- Preliminary analysis for further discussion and revision
  - Inventory of historical emissions from 1990 to most recent data year
  - Projection of emissions to 2020
- Prepared by CCS for Colorado Department of Public Health & Environment (CDPHE) under contract to the Western Regional Air Partnership (WRAP)

# Voting on Priorities for Analysis

- Each PWG member received a ballot via email
- Each respondent cast 10 votes, with no more than one vote per option
- 16 PWG members responded out of 21
- CCS compiled results & identified top 11 options (10 & 11 were tied)

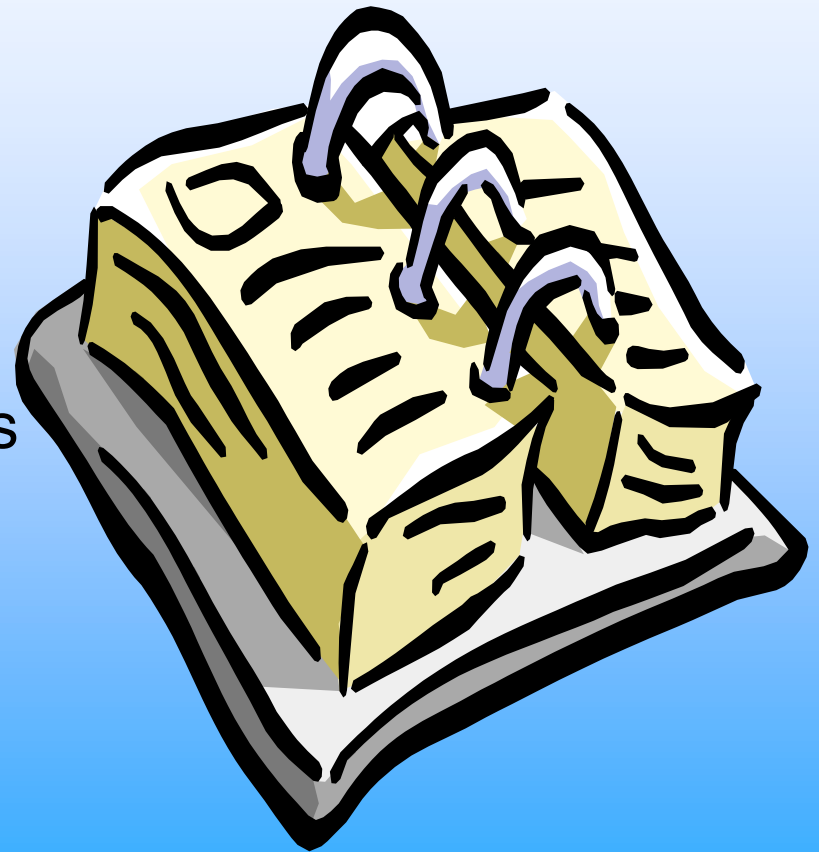
